

ALLEN WHITT IS WEAVING A NARRATIVE OF LIES

OVERVIEW: Senator Shelley Moore Capito has voted with the National Right to Life 100% of the time during her tenure in the U.S. Senate. This is why she has the endorsement of both West Virginians for Life and the National Right to Life. Senator Capito has an “A” rating from Susan B Anthony List. In both 2018 and 2019 she has a 100% voting record with the Family Research Council . Just this year, she received the American Conservatives Union’s Award for Conservative Excellence.

OBAMACARE REPEAL: Whitt is lying about Senator Capito’s record on Obamacare Repeal. She has always been for and voted for the repeal and replace of Obamacare. In the Senate, Senator Capito never blocked a vote to defund Planned Parenthood. He is conflating a series of votes that took place on Obamacare repeal. In fact, Capito voted for the motion to proceed on repeal that passed the Senate with Vice President Pence casting the deciding vote (Roll Call Vote 167, 7/25/17). This vote was the only vote on Obamacare scored by the National Right to Life where Senator Capito has a 100% voting record. She voted to repeal and replace Obamacare and defund Planned Parenthood (Roll Call Vote 168, 7/25/17).

SUPPORT FOR JUSTICE KAVANAUGH: Whitt is making stuff up and spreading rumors about Senator Capito’s support for Justice Kavanaugh. She voted for confirmation which was another vote scored by the National Right to Life where Capito has a 100% voting record. She never made any statement that her reason was because he stated he would not overturn Roe v. Wade.

TAXPAYER FUNDING OF ABORTIONS: As a member of the Senate Appropriations Committee, Senator Capito has voted to uphold President Trump’s authority to defund foreign abortion providers. And she has co-sponsored and voted for S. 109 in the current Congress to enact permanent Hyde protections across the federal government

FEDERAL FUNDS TO PAY FOR ABORTION PILL: Senator Capito never voted to protect federal funds for the abortion pill.

DEFUNDING PLANNED PARENTHOOD: In the Senate, Senator Capito has voted five times to defund Planned Parenthood. She also voted for a resolutions of disapproval signed into law by President Trump to overturn an Obama Administration rule that sought to force states to fund Planned Parenthood through the Title X program.

ENDORSEMENT OF A PRO-CHOICE PAC. : He doesn’t cite what PAC it is because pro-choice PAC like NARAL or Emily’s List did not endorse Senator Capito in 2014. Senator Capito did receive support from a wide variety of organization in her historic win in 2014.

AMENDMENT 1: Senator Capito did not oppose Amendment one. It is inaccurate for Whitt to claim it passed “despite Capito”.
